**FINAL ORDER**

On October 30 and 31, 2007, a three-judge panel of this Court, appointed pursuant to Section 54.1-3935 of the Code of Virginia (1950) as amended, heard evidence in the above-captioned matter and, on December 13, 2007 entered an Order of a Public Admonition without Terms against the Respondent, Clarence Jordan Ball, III. On January 3, 2008, the Respondent noted an appeal to the Supreme Court of Virginia, resulting in a stay of this disposition during the pendency of the appeal.

By letter, dated April 10, 2008, the Respondent requested that his appeal be withdrawn and by Order, entered April 17, 2008, the Supreme Court of Virginia dismissed the appeal and certified the matter back to this Court.

Accordingly, it is **ORDERED** that the Public Admonition without Terms previously entered on December 13, 2007 is hereby reinstated.

Pursuant to Part Six, Section IV, Paragraph 13.B.8.c of the Rule of the Supreme Court of Virginia, the Clerk of the Disciplinary System of the Virginia State Bar shall assess costs.


This cause is final, ended and stricken from the docket of this court.




