AFFIDAVIT DECLARING CONSENT TO REVOCATION

Shane Lee Jimison, after being duly sworn, states as follows:

1. That Shane Lee Jimison was licensed to practice law in the Commonwealth of Virginia on April 24, 2004;
2. That Shane Lee Jimison submits this Affidavit Declaring Consent to Revocation pursuant to Part 6, Section IV, Paragraph 13-28 of the Rules of Court.
3. That Shane Lee Jimison's consent to revocation is freely and voluntarily rendered, that Shane Lee Jimison is not being subjected to coercion or duress, and that Shane Lee Jimison is fully aware of the implications of consenting to the revocation of his license to practice law in the Commonwealth of Virginia;
4. Shane Lee Jimison is aware that the bar is investigating five complaints, the specific nature of which is as follows:
 - a. Shane Lee Jimison's license to practice law was suspended on December 3, 2014;
 - b. Shane Lee Jimison failed to notify all clients of his suspension as ordered by the Disciplinary Board and as required by Part 6, Section IV, Paragraph 13-29 of the Rules of Court;
 - c. Shane Lee Jimison failed to make appropriate arrangement for the disposition of all matters in his care in accordance with the wishes of his clients as ordered by the

Disciplinary Board and as required by Part 6, Section IV, Paragraph 13-29 of the Rules of Court;

d. In a February 19, 2015 Affidavit, Shane Lee Jimison certified to the Clerk of the Disciplinary System that he had complied with Paragraph 13-29 when he knew that he had not complied;


e. Shane Lee Jimison has failed to refund or transfer to new counsel unearned fees to several former clients, despite repeated promises to do so;

f. Shane Lee Jimison continued to practice law following the suspension of his law license on December 3, 2014 and continued to hold himself out as a lawyer to certain clients.

5. Shane Lee Jimison acknowledges that the material facts set forth above and upon which the allegations of misconduct are predicated are true; and



Shane Lee Jimison submits this Affidavit and consents to the revocation of his license to practice law in the Commonwealth of Virginia because he knows that if the disciplinary proceedings based on the said alleged misconduct were brought or prosecuted to a conclusion, he could not successfully defend them.
