## AFFIDAVIT DECLARING CONSENT TO REVOCATION

Pursuant to Rules of Court, Part Six, § IV, ¶ 13-28, Gerald Isadore Katz submits this Affidavit declaring his consent to the revocation of his license to practice law in the Commonwealth of Virginia.


1. Gerald Isadore Katz ("Katz") was licensed to practice law in the Commonwealth of Virginia on September 30, 1975.
2. Katz was also licensed to practice law in Maryland until May 11, 2015. On that date, the Court of Appeals of Maryland, by *Per Curiam* Order, disbarred him from the practice of law in Maryland. Katz submits that the action of the Court of Appeals of Maryland was contrary to that Court's recent precedent.
3. As a result of his disbarment in Maryland, the Virginia State Bar initiated a Rule to Show Cause to revoke Katz's license to practice law in the Commonwealth of Virginia and suspended Katz's license to practice law in Virginia on September 24, 2015.
4. Katz's consent to revocation of his license to practice law in the Commonwealth of Virginia is freely and voluntarily given. Katz is not and has not been coerced or subjected to duress to consent to revocation, and he is fully aware of the implications of consenting to Revocation.
5. Katz acknowledges that he does not dispute the material facts upon which his license to practice law in Maryland was revoked.
