**IMPAIRMENT SUSPENSION ORDER**

This matter came for consideration upon the Petition To Suspend License For Impairment filed by Alfred M. Tripp, by counsel, pursuant to the Rules of Court, Part Six, § IV, ¶ 13.I.6.

The Board has received uncontradicted evidence of Impairment from a health care provider that Petitioner is unable to practice law. Upon consideration of the representations made in the Petition and supporting medical representations, the Board finds by clear and convincing evidence, that Alfred M. Tripp suffers from an Impairment that materially impairs his fitness to practice law. Accordingly, it is

ORDERED that the license of Alfred M. Tripp to practice law in the Commonwealth of Virginia is SUSPENDED indefinitely due to Impairment, the suspension to commence upon entry of this Order. It is further

ORDERED that the Petitioner shall comply with the requirements of Paragraph 13.M. Issues concerning the adequacy of the notice and arrangements required shall be determined by the Board, which may impose a sanction of revocation or further suspension for failure to comply with the requirements of this paragraph. It is further


