

# Virginia State Bar Section Registration Form

Sections of the Virginia State Bar function as separate groups having interests in particular substantive areas of legal practice. Typically, sections sponsor seminars (in conjunction with Virginia CLE), publish newsletters that impart information specific to your legal specialty, and sponsor other activities open to its members. Additionally, they provide the structure by which all members of the bar have the opportunity to participate in bar work.

Membership in each section is open to State Bar members upon payment of modest dues. Each section operates under bylaws approved by the Virginia State Bar Council and broad policy guidelines, also established by the Council.
