

Inside the Office of Bar Counsel:

*To Govern or Be Governed, That is the Question*

In 1887, Henry Ward Beecher declared, "It is for men to choose whether they will govern themselves or be governed." More than one hundred years later, Reverend Beecher's words ring true in the context of attorney self-regulation. Now is the time for lawyers and lay persons to volunteer for service on district committees, the linchpin of the attorney disciplinary process. Without volunteer participation, self-regulation would be an impossibility, and lawyers would necessarily be governed by others.

District committee members can serve two, three-year terms. District committee members must set aside time during regular working hours to participate in subcommittee meetings as well as hearings, and find time to review sometimes lengthy investigative reports and related documents. While district committee service involves a significant time commitment, it is time well spent. Not only is serving the public and the bar a commendable undertaking, applying the Rules of Professional Conduct to real life situations is challenging and often imparts valuable insight into human behavior and the practice of law.

The bar seeks district committee members who are diverse in terms of gender, race, area of practice and firm size. To apply to fill an opening in your district, or nominate another lawyer or lay person for district committee service, please write the senior Virginia State Bar Council member whose name and address head the committee roster. It would be helpful to indicate in

your letter why the candidate is qualified for district committee service and to attach a resume.

Each lawyer candidate will be required to execute a waiver with respect to his or her prior disciplinary record and any pending complaints. Lawyers who have a disciplinary record in any jurisdiction consisting of a revocation, suspension, public reprimand imposed within the last ten years, or private discipline imposed within the last five years are ineligible for appointment.

All candidates must authorize the bar to conduct a criminal records check. Candidates who have been convicted of a felony, any other offense involving theft, fraud, forgery, extortion, bribery or perjury or an attempt, solicitation or conspiracy to commit these acts, or any other criminal act that reflects adversely on the lawyer's honesty, trustworthiness or fitness as a lawyer, are ineligible for appointment.

Virginia State Bar Council members from the respective districts will nominate candidates from their districts this spring. Council will vote on the nominees when it meets on June 14, 2002.
