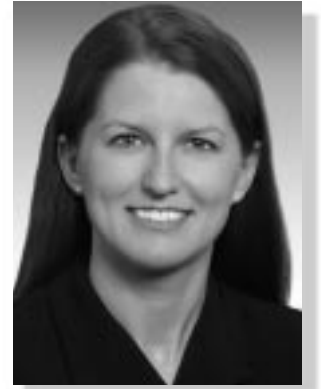


Congratulations and a Farewell

Richard Ottinger is Young Lawyer of the Year



Norfolk lawyer Richard H. Ottinger received the 2003 R. Edwin Burnette, Jr., Young Lawyer of the Year Award on Friday, June 20, 2003, at the VSB annual meeting in Virginia Beach.

The award is presented annually by the VSB Young Lawyers Conference for outstanding service to the conference, the legal profession and the community. The award is named for Lynchburg Judge R. Edwin Burnette, Jr., past president of the VSB (1993–1994) and the YLC (1985–1986).

Ottinger is an associate at the Norfolk office of Vandeventer Black, where his practice focuses on commercial litigation. He volunteers more than 125 hours a year to a variety of community

projects. In addition to providing pro bono representation to Tidewater Legal Aid, Ottinger serves as co-chair to both The Virginia Bar Association Young Lawyers Division disaster legal assistance relief committee and the Tidewater pro bono hotline. He also volunteers for the Hampton Roads Chamber of Commerce, the Chrysler Museum of Art, Norfolk Academy, the YMCA and Norfolk Public Schools.

Ottinger is the 2002 co-recipient of the Norfolk & Portsmouth Bar Association's Walter E. Hoffman Community Service Award, which is awarded to young lawyers who dedicate significant time to benefit the community. He is a past chair of the Norfolk & Portsmouth Bar Association's Young Lawyers Section, a member of the executive council of the VBA Young Lawyers Division and author of, "When is Broad Too Broad? Environmental Law and Policy Review." Ottinger is also a member of the class of 2002 of the Thomas C. Sorensen Institute for Political Leadership at the University of Virginia.
