## Report of the Executive Director/Chief Operating Officer

#### Membership

As of mid-July 2023, the Virginia State Bar's (VSB's) active membership stood at 33,464. Associate membership added 13,153 additional lawyers, and there were 982 judges. These figures represented new baseline numbers of lawyers in the VSB.

Chidi I. James became the president of the Virginia State Bar on July 1, 2023. He is a trial lawyer with the law firm of Blankingship and Keith in Fairfax. He is a past president of the Northern Virginia Black Attorneys Association, a former Vice-Chair of the VSB's Standing Committee on Lawyer Discipline, a former member of the VSB's Fifth District Disciplinary Committee, a former faculty member of the VSB Harry L. Carrico Professionalism Course, and a Board member of the Virginia Trial Lawyers Association. A more complete bio may be found on the firm's website. He is the first African American man, and first post-9/11 era military veteran, to be president of the VSB.

Michael M. York of the law firm Wehner & York in Reston was unopposed in filing a nominating petition with the VSB executive director on or before March 15, 2023. Therefore, in accordance with the Bylaws of the VSB, Part I, Article III, Sec. 3, he was elected at the June 2023 Annual Meeting as the next president-elect of the VSB (2023-2024). Before practicing law, Mike was a Pulitzer Prize winning journalist.

Stephanie E. Grana became the immediate past president of the VSB on July 1, 2023. Stephanie is a trial lawyer with the law firm of Cantor Grana Buckner Bucci in Richmond. She is past president of the Virginia Trial Lawyers Association, the Lewis F. Powell, Jr. American Inn of Court, and the Metro Richmond Women's Bar Association. #### Supreme Court of Virginia Developments

The Hon. Wesley G. Russell, Jr., of the Virginia Court of Appeals, was elected by the General Assembly to serve as a justice of the Supreme Court of Virginia and began his 12-year term on July 1, 2022. Justice Russell was a deputy attorney general for the Commonwealth and a partner at the law firm of McSweeney, Crump, Childress & Temple PC before joining the Virginia Court of Appeals in 2015. He attended the University of Virginia before receiving his law degree from George Mason University School of Law. He previously served on the Board of Governors of the VSB's Section on the Education of Lawyers

The Hon. Thomas P. Mann, of the Fairfax Circuit Court, was elected by the General Assembly to serve as a justice of the Supreme Court of Virginia and began his 12-year term on August 1, 2022. Justice Mann joined the Fairfax Court in 2016 after first serving as a judge for the 19th Judicial District's Juvenile and Domestic Relations District Court. He graduated from New York University and received his law degree from American University College of Law. He previously served on the faculty of the VSB's Professionalism Course.

#### **General Assembly Developments**

Virginia Senator Scott A. Surovell advanced a bill (SB 1494) in February 2023 that would have altered the process for a revoked lawyer to petition for license reinstatement. The existing process outlined in Part 6. Section IV, Paragraph 13-25.E, provided that a revoked lawyer (Petitioner) must have filed a petition with the Clerk of the Disciplinary System who then would set the matter to be heard by the Disciplinary Board for a recommendation to the Supreme Court for ultimate disposition. The bill would have provided a Petitioner with an opportunity to present the case for reinstatement to a three-judge circuit court in lieu of the Disciplinary Board. Further, if the Petitioner's license was not reinstated, he/she could appeal the three-judge decision to the Court of Appeals of Virginia and, if still unsatisfied, to the Supreme Court. The bill, as amended, can be found on the Court's website. Further, the bill would have also introduced a right of appeal to the Court of Appeals of Virginia in all lawyer discipline cases. The VSB did not seek to take an official position on the bill, and it passed the Senate by a vote 25-14-1. (YEAS--Barker, Bell, Boysko, Deeds, Ebbin, Edwards, Favola, Hanger, Hashmi, Howell, Lewis, Locke, Lucas, Marsden, Mason, McClellan, McPike, Petersen, Rouse, Ruff, Saslaw, Spruill, Stanley, Stuart, Surovell--25. NAYS--Chase, Cosgrove, DeSteph, Dunnavant, Hackworth, McDougle, Newman, Norment, Obenshain, Peake, Pillion, Reeves, Suetterlein, Vogel--14. ABSTAIN--Morrissey--1.) Ultimately, however, on the last day of the General Assembly session, the bill failed to advance and was left in the House Courts of Justice Committee.

#### **VSB Staff Developments**

**Software:** The VSB underwent three significant software upgrades this year. The first to go-live was the Cardinal Human Capital Management project, a time/attendance and payroll software upgrade implemented by the Commonwealth. This was largely transparent to the membership, but a significant change for staff.

More directly relevant for VSB members were the software implementations for our membership database and our case management system. At the beginning of 2020, the VSB began reviewing proposals to replace the VSB website—which dated to 2006. One vendor, Advanced Solutions International (ASI), provided a proposal that also included an option for a membership database upgrade through its software called "iMIS". Since approximately 2004, the VSB has used a custom-built, on premises, SQL server database called "IBIS" to store data on all 50,000+ VSB members. IBIS had outlived its useful service life and needed to be replaced. At the end of 2020, the VSB engaged ASI to conduct a business process/requirements review to identify a future database solution and decided to replace IBIS with ASI's iMIS Cloud Enterprise (that is correct, IBIS was replaced with iMIS). There were significant delays and setbacks with the iMIS implementation that postponed its go-live date from early-spring 2022 to 2023. Part of the iMIS upgrade incorporated a new website for the VSB with increased integration with the membership database.

Finally, as of early 2022, the VSB engaged software company Litify to upgrade the disciplinary system case management system that is currently processed by IBIS. The implementation for Litify's software remained substantially on schedule and we anticipated a go-live date for Litify at the end of July 2023.

Staffing: The VSB experienced significant staff turnover in 2022 at least partly due to record low unemployment and evolving preferences for telework in the aftermath of the COVID-19 pandemic. Further, there were notable changes in leadership and retirements of senior and long tenured employees. By appointment of the Supreme Court of Virginia, Cameron Rountree assumed the permanent role as executive director/chief operating officer on September 8, 2023, after Karen A. Gould, who had served as executive director/chief operating officer since January 1, 2008, retired. Similarly, Emily Hedrick was promoted to the position of Ethics Counsel after Jim McCauley, VSB Ethics Counsel for decades, and a VSB staff member for over 30 years, retired in October 2022. Likewise, Susan Johnson, a VSB Senior Accountant, retired after 40 years of service in February 2023. At the end of January 2023, new Deputy Executive Director, Janet Van Cuyk, joined the VSB from the Virginia Judges and Lawyers Assistance Program where she served as assistant director.

Even as staff turnover stabilized, and nearly all vacancies were filled by December 2022, the tumult began anew in January 2023. Nevertheless, other key vacancies were filled including, our Director of Information Technology (Nick Kuriger), Assistant Bar Counsel (Tenley Seli, Rich Johnson, and Joe Caturano), Financial

Analyst (Kat Price-Scott), three new Regulatory Compliance Analysts (Ganna Aboutabl, Michaela Smith, and Kate Weaver), Information Technology Specialists (Aidan Stengel, Tiondra Thomas, and Nicholas Benke), and Human Resources Generalist (Deanna Marchand). Office: The VSB's lease at the Bank of America (BOA) building (1111 E. Main Street) in Richmond was set to expire in September 2024. Staff postponed beginning office renewal or relocation discussions until a permanent ED was appointed. This occurred in September 2022, and since then the consensus desire of senior VSB staff was to remain in proximity to the Supreme Court and Capitol. Relatedly, as a matter of public record, it is anticipated that the Supreme Court will begin construction on a new facility on Main Street that will serve both the Supreme Court and the Court of Appeals. As reported in Axios Richmond in January 2023, "the [new Court] structure would replace the Pocahontas Building, demolishing and rebuilding the more modern east wing while renovating and incorporating the west wing." Demolition is anticipated for the spring of 2024 with the building opening in 2028. If the VSB extends the BOA lease through 2031, we would receive tenant improvement allowances to convert underutilized space into a hearing/multi-purpose room as well as add four new offices by converting storage space and adding modest additional rentable square footage.

#### **Rule Changes and LEOs**

Despite being a year of significant transition, there were several Rule changes and LEOs presented.

Part Six, Section IV, Paragraph 20: On March 16, 2022, the Supreme Court of Virginia amended the rule concerning the maintenance of trust accounts. Effective July 1, 2022, attorneys in private practice are required to maintain client funds in identifiable interest-bearing trust (IOLTA) accounts. The interest on these accounts will be paid to Legal Services Corporation of Virginia to "...be used for funding 1) civil legal services to the poor in Virginia, 2) LSCV's administrative expenses, and 3) the creation and augmentation of a reserve fund for the same purposes." Effective July 1, 2023, enforcement of the amendments to Paragraph 20 began.

**Part 1A, Rule 1A:9:** On January 6, 2023, the Supreme Court amended Part 1A, regarding Virginia Legal Aid Counsel, the Rule that allows non-Virginia lawyers to apply for a certificate as a Virginia Legal Aid Counsel to practice in Virginia when employed by a Virginia Licensed Legal Aid Society.

**Part 6, Sec. IV, Paragraph 3:** On January 18, 2023, the Supreme Court of Virginia adopted amendments to Part Six, Section IV, Paragraph 3(c) regarding Judicial class members, effective March 18, 2023. The rule addressed concerns that the existing rule was both underinclusive — by excluding certain judges, and overinclusive — by including occupations that do not require a law license.

Part 6, Sec. IV, Paragraph 13-25: On March 1, 2023, the Supreme Court of Virginia adopted amendments to Part Six, Section IV, Paragraph 13-25(C) regarding Board Proceedings for Reinstatement, effective April 30, 2023. The change permits lawyers who have resigned their licenses to be readmitted by either passing the Bar examination or meeting all eligibility requirements for admission without examination under Rule 1A:1.

Part 6, Sec. IV, Paragraph 13: On May 9, 2023, the Supreme Court of Virginia amended Paragraph 13, regarding the clarification of the term "shall," effective immediately. In an August 16, 2018, Memorandum to the Boyd-Graves Conference, the Committee on Using "Shall" in Legislative Drafting concluded that "shall is susceptible to significant ambiguity and the better practice in legislative drafting would be to eliminate shall

altogether and to use the more precise term intended – such as must, may, will, should, is, or is entitled to." In November 2020, the Supreme Court of Virginia amended the Rules of Supreme Court of Virginia, Parts 1-5A and 7-11, to clarify the meaning of "shall."

**LEO 1898:** On September 19, 2022, the Supreme Court of Virginia adopted Legal Ethics Opinion 1898, regarding the use of Cryptocurrency, effective immediately. The opinion concluded that a lawyer may accept client property including cryptocurrency offered as an advance payment for the lawyer's services, provided the lawyer's fee is reasonable under Rule 1.5, and this business transaction with the client meets the requirements of Rule 1.8(a), namely, that the transaction is fair and reasonable to the client, the transaction and terms are fully disclosed in writing in a manner the client understands, the client is advised of the opportunity to consult with independent counsel, and the client's consent is confirmed in writing. When cryptocurrency is being held by the lawyer as an advance fee, the requirements of Rule 1.15 regarding safekeeping client property apply and require that the lawyer take reasonable steps to secure the client's property against loss, theft, damage, or destruction.

**LEO 1897:** On September 19, 2022, the Supreme Court of Virginia adopted Legal Ethics Opinion 1897, regarding replying all to an email when the opposing party is copied, effective immediately. The opinion addressed whether a lawyer who receives an email from opposing counsel, with the opposing party copied in the "to" or "cc" field, violates Rule 4.2 when "replying all" to the email. The committee concluded that this conduct does not violate Rule 4.2 because the sending lawyer has given implied consent to the communication with her client by including the client on the email. A lawyer who does not wish to give such consent should separately communicate with the client, such as by forwarding the email to the client.

**LEO 1899:** On January 6, 2023, the Supreme Court of Virginia adopted Legal Ethics Opinion 1899, Use of Conversion Clause in Flat Fee Agreements, effective immediately. The opinion generally addressed the use of a conversion clause that specifies what fee is earned when a lawyer represents a client on a flat (or fixed) fee arrangement and the representation is prematurely terminated by the client without cause. In the opinion, the Committee concluded that a lawyer's fee agreement with a client may include a "conversion clause" if the client terminates the representation prematurely and without cause. However, a conversion provision must be reasonable and adequately explained to the client. The opinion identified the ways in which a conversion clause can be beneficial to both the client and the lawyer by providing certainty about the client's obligations and the fee earned by the lawyer.


**LEO 1893:** On April 12, 2023, the Supreme Court of Virginia adopted Legal Ethics Opinion 1893, Representing child with parent as "next friend", effective immediately. This proposed opinion addresses possible conflicts of interest when a parent, guardian, or other "next friend" engages a lawyer to represent a minor child in a personal injury case against a tortfeasor, when the parent or guardian may also have a lien for past and future expenses for medical treatment of the child. The opinion concluded that generally there is no conflict of interest because the interests of the parent and the child are usually aligned and the parent's relationship with the child raises a presumption that the parent is acting in the child's best interests. The opinion also gave guidance on the types of conflicts that could arise — when the "next friend" is directing the lawyer's representation in an unreasonable way that is detrimental to the best interests of the child, or there are inadequate assets to compensate both the parent and the child. If there is a conflict between the parent's and child's interests, the child cannot waive any conflict because of their lack of legal capacity, and the lawyer cannot reasonably accept consent of the parent on behalf of the child. In that case, the lawyer may seek appointment of a guardian ad litem to protect the child's interests, may seek judicial approval of a proposed settlement, or may petition a court to appoint a substitute "next friend."

**VSB Bylaws:** On June 15, 2023, the VSB Council approved revised amendments to the bylaws concerning the scope of the executive committee's powers pertaining to the performance review of the executive director as well as the deputy executive director and bar counsel. The revised bylaws were published on the website under <u>Rules and Regulations</u>.

increase. Please note, however, that the VSB invested in a significant membership database upgrade (the first in nearly 20 years) that resulted in a review of how lawyers were classified as members. Accordingly, this increase is more likely a result of that review rather than a genuine increase in active members.

## Report of the President

- Welcoming newly admitted lawyers to Virginia by speaking at the Admission & Orientation ceremonies
  at the Greater Richmond Convention Center along with the Honorable Chief Justice S. Bernard
  Goodwyn, the deans of the Virginia law schools, Chair Etahjayne Harris, YLC President Craig Ellis,
  and VSB staff liaison Mallory Ralston.

Carrico Professionalism courses in Richmond, Alexandria, Norfolk, and Roanoke, along with Judge David Lannetti, VSB staff liaison Maureen Stengel, and a host of amazing volunteer faculty members.
- Taking part in many Better Annual Meeting (BAM) committee meetings and planning discussions, along with Chair Sharon Nelson and VSB Staff liaisons Maureen Stengel and Dolly Shaffner.
- Supporting the importance of lawyer well-being by continuing the work of the VSB Special Committee on Lawyer Well-Being led by VSB Past President Len Heath, Graham Bryant, Hetal Mehta Challa, Macel Janischka, Jay Meyerson, and VSB staff liaisons Crista Gantz and Janet Van Cuyk.

## Report of the Office of Bar Counsel

## Renu M. Brennan, Bar Counsel

## I. DISCIPLINARY STATISTICS – FY 2023 (July 1, 2022, to June 30, 2023)

The number of active Virginia lawyers was 31,842. The bar received 3,081 bar complaints. Complaints decreased 1% compared to July 1, 2021, through June 30, 2022.

Roughly 70% of the complaints were screened out early in the review process, and approximately 15% were dismissed after informal investigation by Intake Counsel. Bar Counsel, the Subcommittees, the Disciplinary Board, and Three-Judge Panels dismissed 308 cases. One hundred sixteen (116) lawyers received private (45) and public (71)<sup>1</sup> discipline. Of the 71 lawyers publicly disciplined, 37 lawyers received public reprimands or admonitions; 20 lawyers' licenses were suspended; and 14 lawyers' licenses were revoked.

# Changes to Disciplinary Procedure, Part Six, Section IV Paragraph 13 of the Rules of the Supreme Court, Rules of Professional Conduct, and Legal Ethics Opinions

Disciplinary Procedure

On March 1, 2023, effective April 30, 2023, the Supreme Court of Virginia (Court) amended <u>Paragraph 13-25.C.</u>, Readmission after Resignation, as follows:

C. Readmission After Resignation. If after resigning from the Bar, a former Attorney wishes to resume practicing law in the Commonwealth of Virginia, the former Attorney must apply to the Board of Bar Examiners, satisfy the character and fitness requirements, and either pass the Bar examination or meet all eligibility requirements for admission without examination under Rule 1A:1. Before being readmitted to the Bar, the former Attorney must also satisfy any membership obligations that were delinquent when the former Attorney resigned.

Effective May 9, 2023, the Court approved the Committee on Lawyer Discipline's proposed amendments clarifying "shall" in <a href="Paragraph 13">Paragraph 13</a>. The revisions implement the "ABC Rule" at Paragraph 13 at the request of the Virginia Rules Advisory Committee.

#### Rules of Professional Conduct and Legal Ethics Opinions

Effective September 19, 2022, the Court approved <u>LEO 1897</u> regarding replying all to an email when the opposing party is copied (Rule 4.2).

Effective September 19, 2022, the Court approved LEO 1898 regarding cryptocurrency.

Effective January 6, 2023, the Court approved <u>LEO 1899</u> regarding use of conversion clause when flat fee representation is prematurely terminated without cause.

Effective April 12, 2023, the Court approved <u>LEO 1893</u> regarding representing child and "next friend" as plaintiffs in personal injury case.

### II. Appeals Decided by the Court

By <u>Opinion</u> issued August 11, 2022, the Court affirmed the Disciplinary Board's Memorandum Order suspending Darren Scott Haley's license for 18 months.

By Opinion issued May 4, 2023, the Court affirmed a Three-Judge Panel's findings that Joseph Taylor Brown violated Rule 1.7(a)(2), Conflict of Interest, by engaging in sexual relations with his divorce client during the representation.

By Opinion issued June 1, 2023, the Court affirmed a Three-Judge Panel's findings that Bradley Glenn Pollack violated Rule 1.15, Safekeeping Property, and Rule 1.16, Declining or Terminating Representation and the Panel's sanction of a six-month suspension. By Order entered August 15, 2023, the Court also denied Pollack's petition for rehearing. After the mandate issues, the Court will remand the matter to the Panel to set the effective date of Pollack's six-month suspension.

#### III. Appeals Decided by the Fourth Circuit

On December 28, 2022, the Fourth Circuit disbarred Rhetta Daniel pursuant to Fed. R. App. P. 46, its reciprocal procedure. See <u>In re: Rhetta Daniel, No. 19-9512</u> (4th Cir. 2022).

#### IV. Operations

The VSB launched a new website in April 2023, which temporarily disrupted the on-line complaint procedure. The Office of Bar Counsel also implemented a new case management system in late July 2023.

## **Access to Legal Services**

The Committee on Access to Legal Services (Access Committee) continues to serve the needs of Virginia lawyers and the public by advancing access to legal services.

The Committee met in Richmond on August 30, 2022; in Virginia Beach on October 20, 2022; virtually on January 31, 2023; and in Richmond on April 19, 2023.

The Committee undertakes its work to advance access to legal services through several subcommittees. This year, the Awards subcommittee met on April 11, 2023. The Outreach & Education subcommittee met on December 8, 2022.

We hosted our annual Pro Bono Conference on October 19, 2022, which included four CLE sessions and joint plenary sessions in partnership with the VPLC Statewide Legal Aid Conference. The Committee hosted several other training sessions throughout the year in partnership with VSB sections, conferences, legal aids, and bar associations.

The pandemic thwarted our efforts to present awards in person in 2020, so we honored both 2020 and 2022 award recipients at the Conference. The Access Committee gave out four awards: the 2020 Lewis F. Powell Jr. Pro Bono Award to Clifford "Chip" Clapp and Bary Hausrath, the 2020 Frankie Muse Freeman Organizational Pro Bono Award to Freddie Mac Legal Department, and the 2022 Lewis F. Powell Jr. Pro Bono Award to Chip Nunley. The awards presented in-person on June 15th at the Virginia State Bar Access to Legal Services 30th Anniversary Dinner in Virginia Beach as part of the VSB's Annual Meeting were: the 2023 Legal Aid Award was presented to Tamara Moore, the 2023 Oliver White Hill Law Student Pro Bono Award was presented to Elizabeth Faris, and the 2022 Frankie Muse Freeman Organization Pro Bono Award went to Dominion Energy. Also recognized were attorneys who successfully completed the VSB GetTo30! Pro Bono Challenge. These individuals devoted at least 30 hours of pro bono service and/or contributed at least \$270 to legal service organizations from July 1, 2022, to March 31, 2023.

Virginia Free Legal Answers continues to be a reliable source of quality pro bono advice and counsel for Virginians with civil legal issues. Attorneys and clients can utilize the portal from their home or office, a much-needed resource for those unable or uncomfortable with in-person legal services. The Committee is proud of these accomplishments and looks forward to advancing access to legal services through this important pro bono service even further in the upcoming bar year.

The Access Committee is grateful for the work of dedicated public servants who have devoted their professional lives to the equal justice cause. We also thank the Virginia attorneys who take on pro bono work or make financial contributions to legal aid and pro bono organizations during this time of unprecedented need. We are proud of the significant contributions from Virginia attorneys.

## **Budget and Finance**

## Marni E. Byrum, Chair

The Standing Committee on Budget and Finance met January 12, 2023, to review and approve the proposed FY 2024 operating budget, commencing July 1, 2023.

On February 25, 2023, the Council considered and approved, an operating budget of \$16.8 million for FY 2024. Chief Justice S. Bernard Goodwyn communicated the Supreme Court's approval of the FY 2024 proposed budget on April 5, 2023, to Cameron M. Rountree, Executive Director and Chief Operating Officer.

The approved FY 2024 budget estimates \$16.8 million in expenditures. This is an increase of approximately \$1.17 million over the FY 2023 budget. The increase is primarily due to an increase in salaries and benefits related to a 5 percent salary increase for state employees and \$264,000 earmarked for office renovations.

The Standing Committee on Budget and Finance continues to evaluate the appropriate levels of reserves and dues for the Bar.

## Lawyer Discipline

## R. Braxton Hill IV, Chair

The Committee on Lawyer Discipline11 (COLD), 10 lawyers and two non-lawyer volunteers, worked this year with the Office of Bar Counsel and Clerk of the Disciplinary System on two sets of amendments to Paragraph 13. COLD also worked on district committee training and the Disciplinary Conference, the annual training of all district committee and board volunteers. The Committee also continued to monitor the efficiency of the system, and whether Bar Counsel is moving cases as set forth in COLD's aspirational deadlines, by its in-person review and discussion of cases at its four meetings and by its review of detailed monthly reports from Bar Counsel. These reports include current data and comparative data from past years.

COLD met in person in September 2022, January 2023, and April 2023. COLD met remotely in May 2023. COLD and the Rules Subcommittee completed work begun in Fiscal Year 2022, implementing the "ABC Rule" at Paragraph 13 at the request of the Virginia Rules Advisory Committee. COLD worked with Bar Counsel to replace shall with the more precise term intended – such as must, may, will, should, or is. On February 25, 2023, VSB Council approved the full amendment to Paragraph 13. By Order entered and effective May 9, 2023, the Supreme Court of Virginia ("Court") approved the amendment.

At its April and May meetings, COLD and the Rules Subcommittee vetted and approved amendments to add specific mechanisms for respondents to request three-judge panels for all attorney disciplinary proceedings. VSB Council approved these amendments on June 15, 2023. The petition was filed with the Court for consideration in its August session.

The Oversight Subcommittee continued its monthly reviews of random closed files and additional files referred for review by the Clerk's Office and the Office of Bar Counsel. COLD and the Oversight Subcommittee studied the criteria and standards regarding the Oversight review process and considered adding a category of review of respondents with multiple dismissals of complaints, which will be considered by COLD in the upcoming fiscal year.

The Standing Committee on Legal Ethics meets regularly to consider attorneys' formal requests for advisory opinions seeking guidance on legal ethics and the unauthorized practice of law as well as to analyze and debate proposals to amend the Rules of Professional Conduct and the Unauthorized Practice Rules.

Brett Marston, Jeffery Mitchell, Michael Robinson, and Nia Vidal. VSB staff liaisons are Emily Hedrick, Dorian Dalton, and Krista Mathis Samuels. Longtime staff liaison Jim McCauley retired from the VSB on November 1, 2022.

The committee's activities this year included:

- LEOs 1897 (Replying All to an Email When the Opposing Party is Copied) and 1898 (Accepting Cryptocurrency as an Advance Fee for Legal Services) were approved by the Supreme Court on September 19, 2022, effective immediately;
- LEO 1899 (Use of Conversion Clause in Flat Fee Agreements) was approved by the Supreme Court on January 6, 2023, effective immediately;
- UPL Opinion 219 (Non-lawyer Entity Representation in Practice Before State Agency) was approved by VSB Council on June 15, 2023, and the opinion is pending review by the Supreme Court; this opinion was based on an opinion request from a VSB member.
- Drafting and adoption of LEO 1893 (Representing Child with Parent as "Next Friend"), approved by the Supreme Court on April 12, 2023, effective immediately;
- Released LEO 1900 (Duty to Disclose Death of the Client) for public comment;
- Released proposed Rule 8.4(f), prohibiting agreements not to file bar complaints, for public comment;
- Withdrew UPL Opinions 160 and 178 as they have been superseded by Rule 1A:5 (Corporate Counsel)

The committee also received one new request for a UPL opinion and three LEO requests; all were resolved by directing the inquirer to existing rules and opinions or identified as legal questions beyond the committee's purview.

#### The ethics hotline received 5,917 inquiries this year.

Mr. York and Ms. Dougherty will continue as chair and vice chair for the upcoming fiscal year. There is no change to the committee membership.

## **Professionalism**

## Hon. David W. Lannetti, Chair

The Standing Committee on Professionalism is charged with the execution, administration, and ongoing oversight of the mandatory Harry L. Carrico Professionalism Course, which all newly admitted active members of the Virginia State Bar ("VSB") are required to attend. The purpose of the course is to encourage attorneys to uphold and elevate the standards of honor, integrity, and courtesy in the legal profession. Since the inception of the program in 1988, over 44,000 new admittees have attended one of the 223 courses offered.

The Committee has not seen any significant impact from the extended compliance period instituted following the COVID pandemic. VSB staff members continue to notify members of their compliance time and schedule individuals for appropriate courses. The new database introduced in April 2023 has presented some challenges to tracking compliance data, and staff members are working to resolve all data issues.

During the past year, courses were held in Roanoke, Alexandria (2), Norfolk, and Richmond (2). There were approximately 963 combined attendees who attended these courses. The Committee was happy to welcome the Honorable Elizabeth W. Hanes, the Honorable Rossie D. Alston, Jr., the Honorable Thomas P. Mann, the Honorable Doris Henderson Causey, the Honorable Jacqueline S. McClenney, and the Honorable Charles N. Dorsey as luncheon speakers at the courses. Six courses are planned for the 2023-2024 course year.

The Committee coordinated a faculty training session on October 19, 2022, and met on April 25, 2023, to select new faculty members. The Committee selected 26 new faculty members who will be invited to serve for a three-year term and attend a faculty training session this fall. The Committee is pleased that Chief Justice S. Bernard Goodwyn will again invite the nominees to serve as new faculty members.

The Honorable David W. Lannetti has agreed to continue serving as Committee chair and course moderator for the 2023–2024 year.

## REPORTS OF THE BOARDS

## Clients' Protection Fund

## Phillip V. Anderson, Chair

The Clients' Protection Fund (CPF) was established in 1976 to make monetary awards to petitioners who suffered financial losses because of the dishonest conduct of Virginia lawyers. The fund is managed by a 14-member board (Board) appointed by the Virginia State Bar (VSB) Council (Council). The Board is comprised of 13 lawyers and one layperson. Board members investigate all claims for payments from the fund. The Board decides whether to approve or deny each claim.

The total amount paid during fiscal year (FY) 2023 was \$272,996 for 32 claims. The Board denied 9 petitions, and 19 petitions were rejected for not meeting the CPF rule requirements. As of June 30, 2023, there were 34 pending claims.

The total amount paid for the operating expenses of the CPF for FY was \$11,554. In addition, the fund paid \$5,044 for receivership cases initiated by the VSB. The fund began the FY 2023 with a cash balance of \$10,955,223. The current \$5 CPF assessment on all active attorneys added \$162,470. Accumulated interest income for FY totaled \$104,605. The fund received restitution from the attorney general's collections, debt set-off, and individual restitutions in the amount of \$3,436 net of fees for collection services. As of June 30, 2023, the cash balance in the fund was \$10,936,140.

The Board experienced a surge in FY 2023, with more claims than any year since 2006, when it consistently received about 85 claims per year. The upswing in claims was primarily due to claims relating to a deceased family law attorney; relating to an impaired family law attorney; and involving unearned fees charged by a disbarred estate planning lawyer who for years charged clients prepaid fees for handling their estates after they died. The claims involving these three individuals tended to be quite large, \$10,000 to \$20,000, so the Board's payouts also climbed, in addition to the number of claims.

The Board also received a large number of receiverships regarding deceased and disbarred attorneys (more deceased than disbarred). It remains to be seen whether these receiverships will reduce the number of claims submitted to the CPF next FY or whether the CPF will need to pay claims despite the receiverships' attempts to locate and distribute funds that might belong to clients.

The Board continues to work on efforts to increase awareness and educate the public regarding the Fund. We will be hosting the 2024 National Client Protection Organization, Inc.'s (NCPO's) Annual Workshop in Virginia Beach on September 19-20, 2024.

The Board is to be commended for the many hours spent investigating and deliberating claims and for the work of its various committees including the public awareness and strategic planning committees.

## **Mandatory Continuing Legal Education**

The Mandatory Continuing Legal Education Board (Board) was established by the Supreme Court of Virginia in 1985 to administer the Mandatory Continuing Legal Education regulatory program (MCLE) in the interest of public protection. The Board is authorized to adopt regulations and provide general oversight of the program.

The MCLE Board consists of twelve members appointed for three-year terms by the Virginia Supreme Court. MCLE Board members for the 2023 fiscal year included Mark S. Brennan of Richmond (Chair), Michael D. Pierce (Vice-Chair) of Richmond, Henry L. Chambers Jr. of Richmond, Carolyn P. Desai of Warrenton, Matthew D. Green of Richmond, Deanna H. Hathaway of Richmond, Johnny A. Martin of Bristol, Shukita L. Massey of Newport News, Alison R. Mullins of Alexandria, William H. Old of Williamsburg, and Joanna L. Suyes of Richmond. Cameron M. Rountree, Executive Director of the Virginia State Bar, serves as an ex officio member of the Board, Justice Stephen R. McCullough serves as the Supreme Court's liaison to the Board, and DaVida M. Davis, Director of Regulatory Compliance for the Virginia State Bar, serves as the staff liaison to the Board.

The MCLE Board met seven times during FY2023 to consider course applications, attorney requests for extensions and waivers, and other matters integrally related to the administration of the MCLE program in Virginia. Meetings were held virtually and in person. Over the last reporting cycle, the MCLE staff and **Board considered 23,164 course approvals and 36 waiver/extension requests.** 

Despite the hurdles of virtual business meetings, the Board continued to evaluate and focus on larger programmatic and policy matters.

The leadership of the MCLE Board for the upcoming fiscal year will be William H. Old as Chair and Alison Mullins will serve as Vice Chair.

I would like to thank the staff of the Virginia State Bar's Regulatory Compliance Department who carry out the Board's daily administrative operations as well as the MCLE Board members for their voluntary contributions of both time and knowledge.

The BBRC held the following meetings this year: September 21, 2022 - in person March 15, 2023 - virtual

Significant activities the BBRC undertook from July 2022-Jun2023 included:

- BBRC promoted rule of law initiatives; expanded distribution of VSB informational publications; suggested ways to execute the mission statement; monitored developments on legislation; explored issues regarding judicial safety; and collaborated with the Young Lawyers Conference on bench-bar relationship initiatives.
- The proposed amendments to Part 6, Section IV, Paragraph 3 of the Rules of Court defining judicial class membership, an initiative BBRC began in 2022, were unanimously approved by Council and approved by the Supreme Court of Virginia.
- BBRC collaborated with the Conference of Local and Specialty Bar Associations to host the Annual Bar Leaders Institute in March 2023.
- BBRC hosted the first "Coffee with the Judges" at the VSB Annual Meeting on June 17, 2023. More than 25 judges, from all levels of state courts and the U.S. District Court, attended this casual event to promote informal conversation, the sharing of ideas, and networking with members of the Bar.

It was an honor to not only serve on this important committee but especially to serve as Chair. Every member contributes significantly to the committee's work, especially the judges; and we always have robust and thoughtful discussions. We are very proud of our accomplishments this year, especially ushering in the amendments to the Rules of Court concerning judicial class membership, our collaboration with the Conference on Local and Specialty Bar Associations and the Young Lawyers Conference, and what we hope will be the first of many "Coffee with the Judges" at the VSB Annual meeting. I would like to personally thank Stephanie Grana and Jay Meyerson for appointing me as Chair of this important committee the last two years, and I look forward to serving the VSB in other ways moving forward.

Leadership of the BBRC for the upcoming year will change. At the end of my term as Chair, I will rotate off the committee and Nupur Bal will become Chair. A Vice Chair will be voted on by the Committee during our first meeting. There are new members to welcome for next year, but I would like to thank BBRC members Charlene Hinton and Edward L. Weiner whose second terms have expired.

Finally, I would like to conclude by thanking Cameron Rountree, as well as Janet, who joined us in 2023, and Sylvia, the VSB staff liaison.

## Lawyer Insurance

## David Hudgins, Chair

Since 2000, ALPS Property & Casualty Insurance Company has served as the VSB's endorsed professional liability insurance carrier. The Lawyer Insurance Committee (LIC) continues its monitoring of ALPS' financial stability, ALPS' work to aid Virginia lawyers become better practitioners on the risk management front and oversee the VSB Members' Insurance Center's efforts to help VSB lawyers obtain and manage personal (health, life, and disability) lines of insurance.

The LIC met 4 times in FY2022-2023:

September 27, 2022, at the Belle Haven Country Club in Alexandria November 15, 2022, at the VSB office in Richmond February 16, 2023, held virtually via MS Teams May 18, 2023, at the VSB office in Richmond

#### **VSB Members' Insurance Center**

After many years leading the VSB Members' Insurance Center, Bob Spicknall retired, and the program is now led by Debbie Stocks. Debbie is a Senior Client Executive for OneDigital and the Manager of VSB's Members Insurance Center. Debbie, along with Jennifer Stevens, continue outreach to enroll small law firms in group health insurance plans that have far surpassed individual coverage in popularity. The trend continues because group health insurance is a better purchase with stronger benefits and great provider networks than individual health insurance can provide. At the conclusion of the year, Debbie presented recommendations to change the third-party administrator and offer new products including critical care insurance. The Committee expects to take up these proposals at the beginning of next year.

#### **ALPS** and Lawyer Malpractice Insurance

ALPS operates on a calendar-year (CY) basis. As of December 31, 2022, ALPS insured 1,997 Virginia firms out of 10,780 firms nationwide, and 3,931 Virginia lawyers of 21,205 lawyers insured by ALPS nationwide. Gross written premium in Virginia was \$10,120,034; net written premium was \$7,337,502. The ALPS VA book performed strongly in FY2022-2023 with respect to key insurance benchmarks such as combined ratio and claims frequency. ALPS posted assets of \$157,441,129 with policyholder surplus of \$53,148,445. One-hundred and seven claims were reported in Virginia in CY 2022, compared to 88 claims reported in 2021.

ALPS' AM Best Financial Strength Rating was upgraded in FY2022-2023 from A- (Excellent) to A (Excellent), a notable development for an insurance carrier. AM Best is generally regarded as the preeminent rating agency of insurance companies nationwide.

#### Risk Management Report for Calendar Year 2022

Pursuant to our endorsement agreement, ALPS sets aside 3% of Virginia gross written premium to invest in activities designed to aid Virginia lawyers become better practitioners, reduce claims risk and otherwise be aware of growing malpractice traps. ALPS maintains risk management funds in its accounts pursuant to the endorsement agreement. In CY2022, ALPS set aside and expended, in full, in consultation with our Committee, nearly \$275,000 in funds.

#### FY 2022-2023 Risk Management Priorities

The LIC actively works with ALPS in a healthy collaboration to establish risk management priorities annually.

This year, risk management priorities fell into the following areas:

• Annual VSB / ALPS Ethics and Professionalism Tour. The largest tour of its kind, offering 3 free ethics

- credits to all Virginia lawyers annually, generally held in September or October in advance of the CLE reporting deadline. Sessions held through the Commonwealth in-person and ALPS added a virtual offering during the pandemic which has additionally attendance. Attracted 1,800 Virginia lawyers for in-person CLE events in September 2022.
- Webinars. ALPS generally offers 4-6 webinars to Virginia lawyers on trending ethics, professionalism, law practice management and wellness topics. In CY2022, ALPS had 2,276 Virginia registrants for webinars (including virtual Fall tour participants), of with 976 were ALPS insureds and 1,721 being non-insureds.
- On-Demand Library. At present, ALPS maintains approximately 20 programs in its on-demand Virginia CLE library, ranging in length from 60 minutes to 3 hours. ALPS had 141 Virginia registrants complete on-demand programs in CY2022.
- Operational Support for the Virginia Judges and Lanyers Assistance Program. For over 20 years, ALPS has provided \$30k annually to support this important Virginia program helping lawyers and judges in need at their most vulnerable point.
- Risk Management Prevention Hotline. ALPS contracts with Virginia attorney John Brandt to offer VSB
  members a free, confidential service in the event lawyers would like to discussion questions about a
  potential claim scenario, preventative action to avoid a claim, best practices in law practice systems,
  etc.
- Speakers for Risk Management CLE Topics Sponsored by Local Bars, County Bars, Specialty Bars, VSB Sections and other Affinity Bars. Bars throughout the Commonwealth are actively encouraged to reach out to ALPS for content and speakers on subjects in the risk management field. ALPS will identify speakers, pay speakers, and otherwise help such Bars offer this content at no cost to the organization and as a service to members.
- Local Bar Grant Program. ALPS administers a Local Bar Grant Program whereby local Bars can apply to ALPS for funding on initiatives with a nexus to risk management content. This may include inclusion of risk management content at conferences, mentorship programs, wellness programs, etc. Appreciated service of ALPS and the VSB.
- Marketing Risk Management Offerings. ALPS sets aside approximately 10 percent of the budget to ensure all its quality offerings are known and ultimately utilized by VSB members.

## Special Committee on Lawyer Well-Being

## Leonard C. Heath Jr., Chair

In 2022, VSB President Stephanie Grana created the Special Committee on Lawyer Well-Being—a third, smaller special committee as compared to the 2018-19 and 2021-2022 committees of the same name—with a narrow mission to provide suggestions to the Virginia State Bar Professionalism Committee to update the written materials for the Harry L. Carrico Professionalism Course by including information and resources relevant to attorney well-being. President Grana's goal was to incorporate the recommendations contained in the report titled "A Profession at Risk," which was issued in 2018 by the Committee on Lawyer Well-Being of the Supreme Court of Virginia. Among the numerous recommendations made by that committee was that the Virginia State Bar "[m]ake well-being more prominent in the induction of new lawyers to the profession." In furtherance of this goal, that committee proposed "adding a lawyer well-being segment to the mandatory professionalism course in consultation with course coordinators and [Lawyer's Helping Lawyers]."

Four individuals, including veterans of the first two special committees, were selected to carry out the work.

The Committee held several meetings this year to accomplish its discrete goals. Meetings were held on December 12, 2022, February 6, 2023, and April 5, 2023. The work product of the Committee consisted of revisions to the Harry L. Carrico Professionalism Course materials in furtherance of the goals of the 2018 Committee on Lawyer Well-Being of The Supreme Court of Virginia to incorporate lawyer well-being into the course. The Committee's revisions impacted the following Professionalism Course materials.

- 1. Revisions to the Guidelines for Speakers
- 2. Revisions to the Professionalism Course Teacher Manual (five documents)
- 3. Revisions to Professionalism Coursebook (two documents)

The suggested revisions were transmitted to President Grana on April 21, 2023, and presented to the Professionalism Committee on April 23, 2023. The Committee approved the revisions on April 23, 2023, and incorporated them into the official Professionalism Course materials for courses beginning in December 2023.

The Committee thanks the Professionalism Committee for the opportunity to suggest revisions consistent with the goals of the 2018 Committee on Lawyer Well-Being of The Supreme Court of Virginia. The Committee also thanks everyone who has taken up the mantle of wellness and well-being in the legal profession.

## Lawyer Referral

## Jack Harris, Chair

The Virginia Lawyer Referral Service (VLRS) celebrated its 46th year of service as the consumer arm of the Virginia State Bar (VSB). The VLRS began operating on January 1, 1977.

The VLRS was established by the VSB to enhance and to support one of its core missions: "to advance the availability and quality of legal services provided to the people of Virginia."

In the fiscal year 2022-2023, the VLRS answered 18,559 telephone calls, responded to 449 emails and, 89 written correspondences, and provided 1,567 online requests. VLRS staff assisted 5,905 of those consumers with prescreened and prepaid referrals to its active lawyer panel members, resulting in \$515,970 in revenue for the Bar. The VSB Special Committee on Lawyer Referral thanks the 214 VLRS lawyer panel members (past and present) for their service to the Bar and their communities. The VLRS welcomed 40 first-time lawyer panel members this fiscal year and three returning panel members that have not been a panelist for more than two years.

The Special Committee on Lawyer Referral met on November 16, 2022, and April 27, 2023. Committee Chair Jack L. Harris and Committee Members Joseph M. Bowen, Tonia J. Drewery, Amy M. Harber, Mary K. Hayburn, Eden B. Heilman, Angela T. Isabell, and Lena S. Munasifi welcomed newest committee member Deanna H. Hathaway and look forward to her future service. The Committee thanks exiting committee member Todd A. Pilot for his many years of committee participation.

#### The VLRS goals for FY23:

- Expanded panel membership promotion by highlighting the benefits of panel membership and supporting the VSB mission.
- Supporting the VLRS panelists with additional services.
- The goals were met by:
- Waivers and permanently cancelling the VLRS panel membership dues beginning in February, resulting in former panelists returning to the service and bringing in new panelists.
- Offering current and joining panelists two free VSB Section memberships.
- Providing one hour of free CLE ethics credit through the program 'Legal Fees and VLRS 'Best Practices' on March 29, 2023.
- VSB President Stephanie Grana and VLRS staff promoting the benefits of the VLRS panel membership at VSB-sponsored events throughout the Commonwealth.

In coordination with the VSB Conference of Locality and Specialty Bar Associations (CLSBA) and Bar Services, the VLRS staff attended Solo and Small-Firm Practitioner Forums in Winchester (September 2022) and in Abingdon (May 2023), the Bar Leaders Institute (BLI) in Richmond (March 2023), and the Old Dominion Bar Association Conference in Virginia Beach (May 2023). Staff also attended the VSB Techshow in Richmond (April 2023), YLC A&O Ceremony in Richmond (December 2022 and June 2023), and the VSB Annual Meeting in Virginia Beach (June 2023). The VLRS continued panel membership promotion with written materials at the YLC Leadership Institute in Richmond (September 2022); 39th Annual Advanced Family Law Seminar in Richmond (April 2023); VSB Professionalism Courses in Richmond (September 2022 and December 2022), in Alexandria (September 2022 and March 2023); and in Norfolk (May 2023); and the VSB Diversity Conference in Williamsburg (April 2023). The Committee thanks VSB President Stephanie Grana for her support in highlighting the VLRS panel membership benefits at every event she attended.

### **VLRS Marketing Campaigns**

With the assistance of the VSB Communication Department, the VLRS ran semi-monthly ads in Virginia Lawyer: "Join VLRS and Get VSB Section Memberships for FREE" (August 2022), "People need lawyers across the state..." (October 2022 and April 2023), "Bilingual Virginia Lawyers Needed" (February 2023), "We take the calls, you get the clients – Membership Benefits." (June 2023), and "The Virginia Lawyer Referral Service Needs You!", a column by Committee Chair Jack Harris (February 2023). The VLRS also posted ads in VSB conference and section newsletters—Criminal Law News (October 2022, December 2022, and May 2023), Taxation Law Section News (October 2022), Litigation Section News (Summer 2022), Bankruptcy Law Section News (Spring 2023), Military Law Section News (Spring 2022), Trust and Estates Newsletter (Spring 2023), and Senior Lawyers Conference (Spring 2023) — in addition to the Virginia Lawyers Weekly VSB Annual Meeting double June 2023 issues that generated much needed attention for the VLRS.

For consumer awareness, the VLRS distributed 2500 bookmarks and utilized the social media platforms of Reddit, Twitter, and LinkedIn with service and informational ads and posts.

# **Resolution of Fee Disputes**

### Edward S. Whitlock III, Chair

The Virginia State Bar resolution of fee dispute program (RFD) was created as a voluntary program to help attorneys and clients resolve disputes over fees and costs paid, charged, or claimed for legal services provided by a member of the Virginia State Bar (VSB) through mediation or arbitration.

The RFD program benefits VSB members and the public by reducing needless litigation, spurious bar complaints, and Clients' Protection Fund petitions.

The RFD program volunteers include 11 circuit chairs, 116 arbitrators, and 38 mediators.

The VSB RFD received 104 requests for information during fiscal year 2022-2023, which is down by 42 from last year.

Geographical breakdown of requests:

30 percent were for attorneys practicing in eastern Virginia.

43 percent were for attorneys practicing in NOVA.

21 percent were for attorneys practicing in central Virginia; and

6 percent were for attorneys practicing in southside/southwest Virginia.

The VSB Intake office referred 109 cases to the RFD program, which is 58 more than the number referred the previous year.

# Conference of Local and Specialty Bar Associations

The Conference of Local and Specialty Bar Associations (CLSBA) continues to serve the needs of Virginia lawyers by maintaining a mutually beneficial relationship between the VSB and the local and specialty bar associations in the Commonwealth. It sponsors a Bar Leaders Institute each year to help new local and specialty bar officers plan their bar year and assists them with ethical issues, various programs and internal management policies and procedures; sponsors free Solo & Small-Firm Practitioner Forums open to all VSB members; sponsors the following awards: Awards of Merit, Local Bar Leader of the Year, Specialty Bar Leader of the Year, and Bar Association of the Year; maintains an information database; and makes executive committee and staff members available for technical assistance or presentations to local and specialty bars. The conference publishes The Connection online newsletter with information of interest to bar leaders. The CLSBA also edits, prints and distributes the *So You're 18* handbooks, and created the soyoure18.com website, both of which are used by many groups to inform young adults of their rights and responsibilities upon turning 18.

The CLSBA currently has 138 member bars. There are 3 bar associations in Virginia that are not members of the CLSBA. The CLSBA's annual budget for the past fiscal year was \$25,900 and has a remaining balance of \$495. The annual budget for last fiscal year's Solo & Small-Firm Practitioner Forums was \$40,000 and has a remaining balance of \$23,070.

The CLSBA held the following events this year:

The Bar Leaders Institute was presented on Friday, March 10, 2023, at Lewis Ginter Botanical Garden. The Honorable Doris Henderson Causey was our keynote speaker. Topics for the day included Practicing Law is Tough - Warning Signs, Support, Education; Perspectives of Bar Leadership from Across the Commonwealth; Judicial Performance Evaluations; Re-engaging After Covid; Qualities of a Good Bar Leader; Bar Projects Showcase; Resources for Bar Leaders; and Ethics Challenges - Post-Covid and Beyond. She stands alone in Virginia history as the only African American woman to climb from the district court to the Supreme Court of Virginia, and she has done so through her unwavering integrity, dedication, and intellect.

#### 2022-2023 Oliver Hill/Samuel Tucker Pre-Law Institute

The Oliver Hill/Samuel Tucker Pre-Law Institute (HTI) will be held the week of July 9-14, 2023, at the University of Richmond. Named for legendary civil rights attorneys Oliver Hill and Samuel Tucker, HTI reaches future lawyers at an early age (high school) to provide them with exposure and opportunity to explore the legal profession, at no cost to the participants. # **Senior Lawyers Conference**

As of June 14, 2023, the Senior Lawyers Conference (SLC) had 24,522 members, consisting of all VSB members 55 and older and in good standing.

The SLC officers for the 2022-23 fiscal year are: Gary Hancock, Chair; W. Carter Younger, Vice-Chair; Thomas Bell, Secretary; Barbara Anderson, Treasurer; and Peter Burnett, Immediate Past Chair (ex officio).

The SLC's annual recognition brunch was held at the VSB's annual meeting on June 17, 2023, for VSB members who have reached their 50th year of membership. We had a total of 364 members who reached this momentous milestone. We had a total of 19 members attending in person (with guest there were 60 people in attendance).

The SLC maintains and publishes the Senior Virginians Handbook. The 2021 edition is available in print and for download online. The 2021 Spanish language edition is also available in print and online. The editorial staff will initiate revisions to both language editions online throughout the year as necessary changes become necessary. Veronica Williams, Board Member will oversee and is the new liaison for the Senior Virginia Handbook. Requests for copies of the Senior Virginian's Handbook have been robust. The primary method of distribution is at Senior Law Days, but are available to individual lawyers, libraries, hospitals, senior centers, and as a download from the Senior Lawyers Conference's page on the Virginia State Bar website.

Former SLC Board of Governors Chair Bruce Robinson provides leadership and support for bar communities desiring to hold a half day free seminar Senior Law Day Programs (including free copies of the Senior Virginian's Handbook for each attendee) for senior Virginians and their advocates. A template and guide for the program is available on the SLC attorney resources page, and we provide advice on proven presentation strategies. Frank Brown has dedicated significant time and service in producing the SLC Newsletter and oversees the SLC's content in the Virginia Lawyer magazine.

The Conference continues to encourage pro bono work by senior lawyers, through both the Special Committee on Access to Legal Services and Board members' personal efforts. Andrea Bridgeman is now heading our pro-bono efforts as our liaison.

The SLC Pro Bono working group has met and discussed several ways to engage Conference members. These include:

Promoting TIES, Transition into Emeritus Status, to encourage retiring VSB members to provide pro bono service and continue to participate with the Bar (articles in the Senior Lawyers Newsletter and The Virginia Lawyer-12/22 issue, telephone outreach to all current Emeritus VSB members).

Sponsoring/creating webinars about planning for seniors and legal protections for the vulnerable and infirm—proactive legal advocacy for senior lawyers and their clients!

Support for the Senior Helpline, a project of the State Department of Aging and Rehabilitative Services and the Virginia Poverty Law Center, which is coming back on-line after a hiatus; the Helpline provides remote advice and counsel to clients without income restrictions and will need pro bono volunteers to support specific substantive areas. Some ideas being discussed include:

- Creating shorter, low-literacy brochures for callers on several of the topics covered in the Senior Lawyers Handbook.
- Getting a bench of committed SLC volunteers (possibly emeritus attorneys) to cover helpline calls, possibly focused on one or two legal categories.
- Creating a program to recruit and train attorneys to work directly with Afghan immigrants has

- proved challenging.
- Creating a list of those willing to mentor pro bono attorneys (presumably without direct client contact). A model might be the Triage Project, a venture of the Greater Richmond Bar Foundation and Central Virginia Legal Services.

Under the leadership of our Mentoring Subcommittee, Peter Burnett, and Carter Younger, we have made reported considerable progress toward completing the professionalism and civility video. A final draft video is now completed, and the video is excellent and received universal praise from our Board of Governors at our recent meeting. It will be approximately one-hour long and will feature a number of distinguished interviewees, including Virginia's Chief Justice. We are exploring options for awarding CLE credit associated with the video.

Discussions are underway about how best to distribute and grow interest in the video when it is completed in order to maximize the impact of the video. Peter and Carter are exploring marketing strategies to ensure maximum distribution and coverage for the video.

The Senior Lawyers Conference undertook preliminary revisions of its by-laws at the Annual Meeting and will continue review in the coming year.

We thank Judge Manuel A. Capsalis from Fairfield and Mary Lynn Tate from Abingdon for their dedicated service as they rotate off our Board of Governors. We also thank Sylvia Daniel of the VSB staff for her continuing assistance and support of the Senior Lawyers Conference, and we welcome Nancy Donner as the new incoming liaison for the Board of Governors. The Bankruptcy Law Section currently has 632 members. The annual budget for the past fiscal year was \$10,624.00 and has a remaining balance of \$2,927.97.

Topics included White Collar Criminal Issues for the Business Lawyer, Federal Corporate Transparency Act Update, Commercial Contract Disputes Clauses, Avoiding and Handling Business Owner Deadlocks, Disputes and "Divorces", and Ethics for Business Lawyers. The course qualified for 8 hours of CLE credit including 2.0 hours of ethics credit.

#### 7th Annual Federal Government Contracting Seminar

The Section continues to provide valuable written materials to its membership. The Section published its Summer edition of its newsletter under the editorship of Joe Guarino, Chandra Lantz, Arnie Mason, and Dan Eggleston. It has been an honor to serve as chair of the Virginia State Bar's Section on Criminal Law for the 2022-2023 bar year. The section continues to serve the needs for Virginia lawyers by bringing together both defense and prosecution attorneys to produce programming for Virginia lawyers and to share knowledge of the profession.

With a membership of 2,470 members, including 370 judicial members, the section remains the second largest section of the Virginia State Bar. Its operating budget for 2022-2023 was \$41,600.

Newsletter editor Professor Ron Bacigal, of the University of Richmond, published three issues of Criminal Law News during the year and assisted with the annual seminar.

This past year the section enjoyed tremendous success in outreach to and recruitment of talented attorneys of all levels of experience in an effort to expand federal, circuit, and appellate court appointed lists.

The section enjoyed a phenomenal 53rd Annual Criminal Law Seminar in both Williamsburg and Charlottesville and awarded our prestigious Harry L. Carrico Professionalism Award to The Honorable Robert E. Payne, Senior District Court Judge for the Eastern District of Virginia.

For the first time, the Criminal Law Section offered five scholarships to the Young Lawyers Conference for the Annual Seminar. The application included a statement of interest and verification of public service practice. The YLC liaison vetted the applications and proposed 5 recipients who the Board approved. The selection criteria placed some emphasis in the selection process on financial need and practice location/access to live CLEs. Tuition to one of the two seminars was waived and if the recipient lived more than 30 miles away then mileage and hotel fees were also covered. The section also offered mentorship opportunities following the seminar. The young lawyers were excited to be part of the event, our Board was excited to host them, and the cost to our section was minimal. The section also subsequently sent a message to the other VSB section chairs asking that if they host an event of this nature to please consider offering the same opportunity in their field to our YLC colleagues.

This year the section sponsored two CLEs at the VA Beach Annual Meeting. M. Tyson Daniel spoke on behalf of our section at "Budding" Cannabis Law from Four Perspectives: A "Joint" Presentation from the Litigation, Criminal, Health, and Real Property Sections of the VSB. Jennifer Gebler presented on behalf of our section at Protective Orders - Defense and Pleas, which was co-sponsored with the Family Law Section. Both were well received and unique in both the collaborations and the topics.

As part of its ongoing partnership with Virginia law schools, the Section awarded stipends of \$4,000 in June 2023 to the public law schools (George Mason, UVA, and William & Mary) to fund student internships in the field of criminal justice for the summer of 2024.

# Education of Lawyers in Virginia

The Section on the Education of Lawyers continues to serve the needs of Virginia lawyers by bringing together law school deans and professors, members of the judiciary and practicing lawyers in a collaborative effort to provide programs that improve every phase of legal education in Virginia.

The Section currently has 260 members. The annual budget for the 2022-2023 fiscal year was \$5,144.00. The Section ended this fiscal year with a negative balance of \$412.77. The Section's 2023-2024 Budget will begin with a \$6,464.00 balance.

The Section met via video conference in September and November of 2022 and in January and March of 2023 to conduct standard business and develop ways to better-serve section members.

The Section's 2022-2023 programs and accomplishments were as follows:

# **Litigation Section**

The board had its dinner/meeting at Steinhilber's in Virginia Beach on June 15, 2023, where the new board of governors was approved.

The section co-sponsored a 1.5-hour CLE during the VSB Annual Meeting on the topic of "Budding" Cannabis Law from Four Perspectives: A "Joint" Presentation from the Litigation, Criminal, Health, and Real Property sections of the VSB. Speakers were Tyson Daniel, Scott Johnson, Stewart Pollock, and Agustin Rodriguez.

The section offered its members a free CLE on October 13, 2022, 12-1:30 p.m. at Lewis Ginter Botanical Garden. The topic was *Discovery Disputes: How to Avoid Them, Narrow Them, and (if necessary) Litigate Them.* Speakers were the Honorable John Anderson, the Honorable Randy I. # **Real Property Section**

# Karen L. Cohen, Chair

It has been a great honor for me to serve as Chair of the Real Property Section, to follow a long line of outstanding former chairs, and to lead the Section for the 2022-2023 year, along with my terrific colleagues, Vice Chair Sarah Louppe Petcher and Secretary-Treasurer Robert E. Hawthorne, Jr.

I am proud of the Section's accomplishments this past year. I know that with the enthusiasm of the Section's leaders and the momentum from this year's successes, 2023-2024 holds great promise. I am confident that the initiatives we began this year will continue to enrich our members' experiences as real property lawyers in Virginia.

#### Membership & Budget

The section currently has 2,062 members. The annual budget for 2022-2023 was \$36,900 with a balance of \$6,082.10 as of April 30, 2023. The Board voted to raise Section dues from \$25 to \$35, to increase its available budget for a number of new initiatives and programs, discussed below.

#### The Living Library Project

Led by Rick Chess and Larry McElwaine, we began an initiative to create a mentorship program for new attorneys, and out of that effort, the idea evolved to create a video library on real estate law topics that any member – whether new to real estate law or an experienced attorney who is simply curious about a new practice area – could access to learn from seasoned practitioners.

We have dubbed this project "The Living Library" and to date, two videos have been professionally made and edited on Real Estate Litigation and Title Insurance, featuring John Altmiller and Michael Derdeyn.

Our Living Library Subcommittee has been extremely active in the production effort and plans to release the videos every other month beginning in September, with additional videos planned for various topics, including Easements, Land Use and Foreclosure.

#### The Fee Tail

Another highlight of this past year was the introduction of our new quarterly(-ish) electronic publication, *The Fee Tail* is a short email update of recent developments in case law or legislation pertinent to the practice of real estate law in the Commonwealth. Within days of several major Virginia Supreme Court decisions, *The Fee Tail* landed in Section Members' email inboxes to keep our members up to date and informed. We received very positive feedback from our members on this new publication.

#### The Fee Simple

The Section continued its tradition of publishing its journal, *The Fee Simple*, twice a year. In the Fall Issue, we paid special tribute to Felicia Burton's 25 years of remarkable service to the Section as an assistant to the Editor of *The Fee Simple* – as the cover of that issue notes, she was the "wind beneath its wings" for two-and-a-half decades.

In the Spring Issue, we honored the Section's Traver Scholar Award recipient, John David Epperly, Jr. The award is named for Courtland L. Traver, whose outstanding legal ability and willingness to share his knowledge and experience was an inspiration to others. Throughout John David's career, from private practice at McGuireWoods to Virginia State Counsel for Fidelity National Title Group (retiring this past September), John David made significant contributions to the Real Property Section, generously sharing his knowledge with others as a Section member since the late '80s; as Chair of the Section from 2000 to 2001; and as a frequent presenter at seminars on a variety of real estate topics. The Section congratulates John David, and thanks him for all he has done for the Real Property Section.

#### Heirs Property Education & Training

Our Section has made advances in addressing a real property topic that often goes overlooked in law school and professional education – heirs' property and the loss of intergenerational wealth in vulnerable communities that continues to result from a lack of understanding of heir's property issues by landowners and lawyers.

The Real Property Section sponsored a program on heirs' property in 2020 (just before the pandemic). Since then, there has been a growing interest among the real property bar in addressing the inequities and injustices that have arisen from this feature of property ownership.

Several Section members have been working to develop a lawyer training program on how to provide professionally and culturally competent representation to families with heir's property issues. As I noted in the Fall Issue of *The Fee Simple*, we are in a unique position to "answer the call" from our colleague, Karla Carter, who wrote that "[t]he sad history of land loss in low-wealth communities in this country is one that has persisted long enough, and a new narrative is being written, one in which lawyers and judges seek justice for all and where low-wealth communities are able to preserve their family legacies through estate planning and other needed legal services."

An important part of "answering the call" is ensuring that future generations of lawyers are prepared to do the same – and that requires truthful education about the past. To that end, Karla Carter and I, along with UVA law and history professors, and other expert panelists, presented on heirs' property at UVA Law School.

One of our goals as a Section is to encourage more young lawyers to choose a career in real property law. One way to do that is to connect with law students to broaden their view of real estate law, making them aware that property law is intertwined with many issues that are meaningful to them. The presentation at UVA was very successful in accomplishing this goal and therefore, we intend to continue these educational efforts at other law schools in Virginia.

#### **Quarterly Board of Governors Meetings**

We held our regular Fall Meeting of the Board of Governors and Area Representatives on September 9 at the new Virginia Law Foundation-Virginia CLE facility at the Bobzien-Gaither Education Center in Glen Allen. Our Winter meeting was held in March in Williamsburg in connection with the VA CLE Advanced Real Estate Seminar, and our Spring meeting also was held in Williamsburg.

At the Annual Meeting in June in Virginia Beach, we elected our new slate of officers and filled three vacant Board of Governors seats in accordance with our bylaws. For the 2023-2024 year, the Section's officers are: Sarah Louppe Petcher, Chair; Robert Hawthorne, Jr., Vice-Chair; and Rick Chess, Secretary-Treasurer. Three Section Members were elected for the vacancies on the Board of Governors: Cynthia Nahorney; Benjamin Winn; and Vanessa Carter.

### **Trusts & Estates Section**

The Trusts & Estates Section continues to serve the needs of Virginia lawyers by sponsoring educational programs and seminars on trusts and estates law; developing and providing to members bibliographies of materials on trusts and estates law, lists of experts, consultants, research, and standards associations; and providing a forum where section members can share research, source materials, and experiences.

The Trusts & Estates Section currently has 2,201 members. The annual budget for the past fiscal year was \$ 15,360.00 and has a remining balance of \$2,784.11.

In October, the Trusts and Estates Section co-sponsored the 41st Annual Trusts & Estates Seminar with Virginia CLE. The Seminar was held in one location with hybrid attendance also available. It addressed important updates on federal and Virginia tax developments, cases, and legislation. It included topics on An Estate Planner's Perspective of Recent Tax Developments; Virginia Developments in Estate Planning and Administration, Ethics and Estate Planning for Cryptocurrency.

The Trusts and Estates Sections published two newsletters in fiscal year 2022–23. Our Summer 2022 issue featured articles like "The ABCs of GST" which reviewed the estate/gift tax and generation-skipping transfer (GST) tax consequences of lifetime gifts and explained the basic principles of reporting lifetime gifts that are or may be subject to the GST tax.

Our second article "Estate Planning Techniques for Increasing Interest Rates" addressed techniques that can be employed successfully in a high interest rate environment. The third article, "Virginia Supreme Court: Arbitration clauses in Trusts are Not Enforceable Against Beneficiaries" reviewed the Virginia Supreme Court's decision in Boyle v. Anderson. Finally, our last article was "What Do I Do with This Stamp or Coin Collection? Advice for Beneficiaries and Collectors" which provided practical tips on advising clients regarding inherited collectibles with a focus on stamp collections.

We appreciate the hard work and dedication of Emily A. Martin as our newsletter editor and Peter Holstead Davies as our assistant newsletter editor.
