REQUESTING WRITTEN PROMISE
FROM OPPOSING COUNSEL.

Where a client insists on receiving written evidence from his opponent's counsel of that counsel's intent to place monies in controversy in escrow, it is not improper for the attorney for said client to demand such written assurances from opposing counsel.
