CONSENT TO REVOCATION ORDER

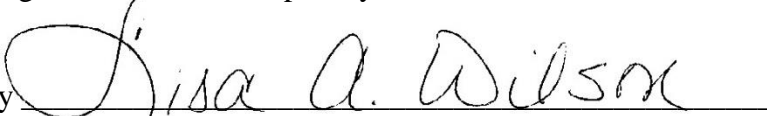

The Board having considered the Affidavit, and Bar Counsel having no objection, the Board accepts his Consent to Revocation.

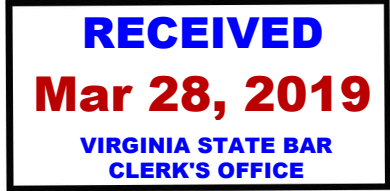

AFFIDAVIT DECLARING CONSENT TO REVOCATION

Gary L. Lumsden, after being duly sworn, states as follows:

1. Gary L. Lumsden has been licensed to practice law in the Commonwealth of Virginia since September 27, 1979;
2. Gary L. Lumsden submits this Affidavit Declaring Consent to Revocation pursuant to Rule of Court, Part 6, Section IV, Paragraph 13-28.
3. Gary L. Lumsden's consent to revocation is freely and voluntarily rendered, that Gary L. Lumsden is not being subjected to coercion or duress, and that Gary L. Lumsden is fully aware of the implications of consenting to the revocation of his license to practice law in the Commonwealth of Virginia;
4. Gary L. Lumsden is aware that there is currently pending a complaint, an investigation into, or a proceeding involving, allegations of misconduct in connection with his representation of Demarcus Brown on certain criminal charges in the United States District Court of the Western District of Virginia, the docket number(s) for which is set forth above.
5. Gary L. Lumsden has been advised of those allegations and has denied any misconduct on his part except for those allegations to which he admits in this Affidavit of Consent to Revocation as set forth below:

a. Gary L. Lumsden took a proprietary interest in an Audi automobile owned by Mr. Brown without complying with the requirements of Rule 1.8 of the Virginia Rules of Professional Conduct and then had it subsequently sold; and

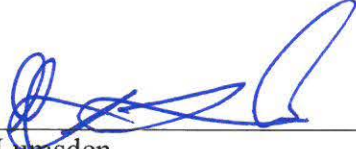
b. Gary L. Lumsden failed to properly hold in trust the sale proceeds of the Audi or otherwise account for them in accordance with the requirements of Rule 1.15 of the Virginia Rules of Professional Conduct.

6. Gary L. Lumsden acknowledges that the material facts upon which the allegations of misconduct in Paragraph 5 (a) and (b) are predicated are true; and

7. Gary L. Lumsden submits this Affidavit and consents to the revocation of his license to practice law in the Commonwealth of Virginia because he knows that if the disciplinary proceedings based on the said alleged misconduct in Paragraph 5 (a) and (b) were brought or prosecuted to a conclusion, he could not successfully defend them.

8. Pursuant to Rule of Court, Part 6, Section IV, Paragraph 13-28.B, the admissions offered in this Consent to Revocation Affidavit shall not be deemed admissions in any other matter or proceeding except one relating to Gary L. Lumsden's status as a member of the Virginia State Bar.
