CONSENT ORDER OF IMPAIRMENT SUSPENSION

This matter came for consideration upon the bar's Petition for Impairment Examination and Releases for Respondent's Psychiatric, Psychological and Medical Records.

Upon consideration of the information contained in the Petition for Impairment Examination and Releases for Respondent's Psychiatric, Psychological and Medical Records and accompanying exhibits, and the agreement of Claude Michael Scialdone as evidenced by the endorsement of this order by he and his counsel, the Board hereby finds that Claude Michael Scialdone suffers from an Impairment as that term is defined in Part Six, Section IV, Paragraph 13-1 of the Rules of the Supreme Court of Virginia.

Based on the foregoing, the consent of Claude Michael Scialdone as evidenced by the endorsement of this order by he and his counsel, and it otherwise appearing proper so to do, IT IS HEREBY ORDERED pursuant to Part Six, Section IV, Paragraph 13-23 of the Rules of the Supreme Court of Virginia, that the license of Claude Michael Scialdone to practice law in the Commonwealth of Virginia SHALL BE AND HEREBY IS SUSPENDED INDEFINITELY upon entry of this Order due to Impairment and shall remain suspended until it is established that he no longer suffers from an Impairment.

It is FURTHER ORDERED that Claude Michael Scialdone shall give notice, by certified mail, of the suspension of his license to practice law in the Commonwealth of Virginia to all clients for whom he is currently handling matters and to all opposing

attorneys and presiding judges in pending litigation, and shall make appropriate arrangements for the disposition of any matters presently in his care in conformity with the wishes of his clients, pursuant to the requirements of Part Six, Section IV, Paragraph 13-29 of the Rules of the Supreme Court of Virginia.

It is FURTHER ORDERED that the Clerk of the Disciplinary System shall send a certified copy of this order: i) by certified mail to Claude Michael Scialdone at his last address of record with the Virginia State Bar: 1238 E. 
