The Section on Education of Lawyers continued its mission of providing a forum for integrating the bench, bar and academia to improve Virginia's legal system. At the annual meeting, our Section co-sponsored a CLE program entitled, "Corporate Meltdown: Counsel in the Hotseat." Panelists included James B. Comey, Jr., United States Attorney, Southern District of New York; George M. Cohen, Edward F. Howrey Research Professor of Law, University of Virginia School of Law; Frederick J. Krebs, President, American Corporate Counsel Association, Washington, D. C.; and N. Pendleton Rogers, Troutman Sanders, LLP, Richmond, Virginia. Thomas E. Spahn with McGuire Woods, LLP, McLean, Virginia, served as the moderator. The Annual Meeting Planning Committee, chaired by The Honorable Pamela Meade Sargent, organized an outstanding program which was well attended and received excellent feedback.

The Professionalism Course for Law Students, developed by our Section and the Standing Committee on Professionalism, was again offered to first year students at each of Virginia's seven law schools. All sessions were well attended, and student evaluations were positive. Justice Kinser, chair of the Education During Law School Committee, and her committee are to be commended for their help and participation in the programs. The Honorable B. Waugh Crigler and Professor Michael I. Krauss, George Mason School of Law, were presented resolutions recognizing them for their dedication in developing and implementing this program.

Ed Lowry continued as chair of the Emerging Trends Committee. After examining the broad body of work in this area, the committee decided to hold a symposium on the topic of "Creating and Maintaining the Complete Lawyer." Representative lawyers, jurists, and academicians will be invited to

attend. It is hoped that the symposium will generate ongoing discussion culminating in a statewide program.

Professor Eric DeGroff continued to do an outstanding job as editor of the Section's newsletter. Two editions were published.

Virginia's seven law schools contribute to the Section's annual operating budget. Support is also sought from law firms. This year's Fundraising and Law Firm Contributions Committee, chaired by Ray Diaz, did an excellent job of soliciting support for the Section's programs. (delete last phrase.)
